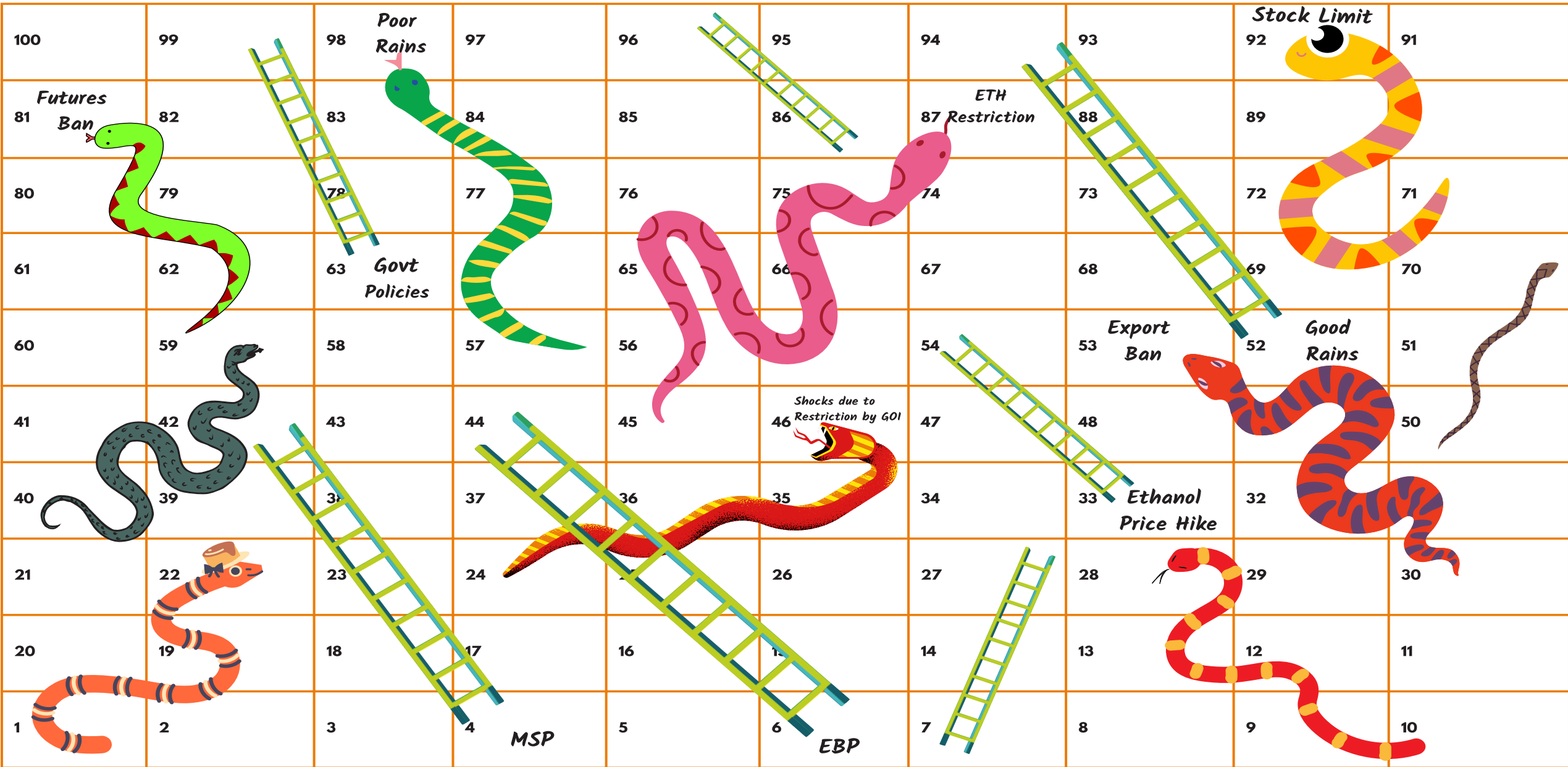

# Way Forward.....



- India as a **Global Sugarcane Superpower** should aim to become a superpower in sugarcane by ensuring robust production that caters to domestic sugar and ethanol industries while maintaining surplus for exports.
- **Continued molasses exports** to Europe, where Indian molasses is a preferred choice for animal feed, will not have an adverse impact, as its contribution to ethanol blending from CHM is negligible.
- Equilibrium between prices—i.e., FRP, MSP, and ethanol—will ensure the health of the industry and serve the interests of both consumers and farmers.
- **FRP has been increased by 34% since last revision of Sugar MSP and increased by 11% since prices of ethanol SCJ and BHM were revised in 2022.**

**Healthy Industry = Prosperous Farmers = Satisfied Consumers = Sustained Export Presence**

**India's sugar industry must be strengthened to sustain growth, support exports, and drive the transition towards a cleaner energy future.**
